### ITEM VI – DISCUSSION/ACTION ITEMS

a. Southside Proposition 28 Arts and Music Funding Plan (ACTION)

Rationale: The proposition 28 Arts and Music in schools act provides funding for arts education. Each school is required to submit an annual board approved report that details the types of arts education programs funded by the program. The plan must identify the number of full-time equivalent (FTE) teachers, classified staff, teaching aides, and students served. The current plan focuses on a performing arts dance education program for the 2024-2025 school year. Mr. Schilling stated that the plan could be amended at any time.

Recommended Motion: That the board approve the Southside Prop 28 plan for the 2024-2025 school year.

Aaron Kaelin made the motion to approve the Southside Prop 28 plan for the 2024-2025 school year and was seconded by Jessica Kim and carried the following vote: Yes -5; No/Absent 0/Abstain -0

b. Southside Kitchen Grease Trap (ACTION)

Rationale: The grease trap in the Southside kitchen is the original container installed when the building was constructed. The trap is showing signs of deterioration and failure. To avoid extensive damage and possibly large costs to fix leaking and damage to the subfloor, it is recommended that we explore our options for replacement or repair. We are currently seeking bids for an assessment of the trap system and repair solutions. It is recommended based upon the extent of the possible damage that the district act quickly to avoid further damage or increase costs. It would be in the best interest of the district to approve advanced funding to allow for replacement or repair costs. An estimate of \$10,000 is recommended.

Recommended Motion: That the board approve the amount, not to exceed \$10,000, in emergency funds to address issues with the Southside grease trap.

Julio Salazar made the motion to approve the funding for the grease trap replacement not to exceed \$10,000 and was seconded by Julie Corrigan and carried the following vote: Yes -5; No/Absent 0/Abstain -

d. Southside Parent Club School Connected Organization (ACTION)

Rationale: The Southside parent club school connected organization application for the 2024-2025 school year is needed to authorize the parent club as a partner organization to support the school. School connected organizations are organized and operate independent of the district. The district is not responsible for and assumes no liability for the programs, fundraising or other activities of a school connected organization.

Recommended Motion: That the board approve the Southside Parent Club school connected organization application for the 2024-2025 school year.

Julie Corrigan made a motion to approve the school connected organization application and that the Parent club needed to add Southside as the certificate holder as additionally insured on the Parent insurance policy. Jessica Kim seconded the motion and carried the following vote: Yes – 5; No/Absent 0/Abstain –
